To Our Valued Endowment Donors:

The DASF Endowment Committee would like to update you on the status and progress of The Shelter Endowment Fund, initiated in Fall 2015 by Dr. Jerry and Shirley Watson in memory of their beloved dog Kandi.

The purpose of the endowment fund is to provide the Linda McNatt Animal Care and Adoption Center access to grant funds for the benefit of the shelter pets in perpetuity. The fund is overseen by the Endowment Committee which is composed of both DASF Board members and non-board member stakeholders.

As noted in the DASF Year-in-Review July 2019- June 2020, the committee and the DASF Board of Directors approved the engagement of Cultivar Capital, Inc. as the financial advisor and investment manager of the endowment funds. Mr. Thomas Muir, CPA, CFP and President of Cultivar joined the committee to provide expertise for long term growth of the funds and maximized return on investments.


The last five years has seen substantial growth in the endowment while also providing the shelter with grants from a portion of annual revenue - for special needs/projects identified and requested by shelter management.
