





IT WAS ONLY A VISION, UNTIL DASF MADE IT HAPPEN

Denton Animal Support Foundation was founded in 2006 by community volunteers and philanthropists Ms. Bette Sherman and Ms. Pete Kamp. The foundation was originally chartered as the Denton Animal Shelter Foundation. In 2015, DASF amended the charter with the Texas Secretary of State to be renamed Denton Animal Support Foundation (DASF). The name was revised to better reflect the broader purpose and goals of the foundation after the new shelter was opened.

In 2011, DASF donated \$2.2 million to the city toward building and equipping the Linda McNatt Animal Care & Adoption Center (City of Denton Animal Shelter), replacing the outdated and overcrowded 30-year-old city shelter. The new shelter opened in January 2015. Since then, DASF has continued to annually donate over 50% of the foundation's fundraising to the shelter for adoption programs, pet medical, and equipment/furniture upgrades or replacements. Additionally, DASF continues to provide marketing/PR support for pets through social media and paid advertising.

Thanks to our amazing donors, supporters, and volunteers – as well as our hard-working Board and staff – thousands of pets are saved or serviced annually. In addition, pet owners receive support in order to keep their pets at home, healthy, and safe. Donors receive regular updates on progress and a Year-In-Review Report is published annually.




CONGRATULATIONS GRADUATE!

THE DASF SHELTER ENDOWMENT FUND A LEGACY OF LOVE

This special fund provides financial assistance to the pets in the Linda McNatt Animal Care & Adoption Center, both current and for the future. 
ADOPTION SUBSIDY PROGRAM IN ACTION

From July 2022 - June 2023, DASF sponsored \$20 adoptions for shelter pets at the City of Denton Linda McNatt Animal Care & Adoption Center through the Adoption Subsidy Program, and over **840 pets were adopted.**

Cyntoia had been at the shelter for 3 months. She is blind in one eye and tested positive for heartworms, making it a little more difficult to find her forever home. All homeless pets — including those who are older, shy, or have special needs — deserve homes, and some need a little extra help to find them. Thanks to DASF's Adoption Subidy Program, Cyntoia found a loving home.




